


is a social service agency with a mission to improve the quality of life of children with cancer and their families and children impacted by cancer through enhancing their emotional, social and medical well-being.



Asfa's favourite activity is dressing up. She loves picking out her outfits to match with accessories like hair bands, bags and necklaces. These were some of the joys that cushioned Asfa in her tough fight against childhood cancer.

Diagnosed with Leukaemia when she was only two, the sudden change to a hospital environment brought young Asfa much anxiety as she was constantly surrounded by nurses and doctors for tests and treatments. Her mother Azleen recalled how Asfa would often cling tightly her, wishing the nurses trying to connect her plugs would go away.

To prevent Asfa from developing a fear of visiting the hospital, Azleen decided to associate hospital visits with dress-up sessions. Together with CCF's therapeutic play sessions that helped Asfa better understand the treatment processes, her anxieties were eased.

Asfa conquered cancer and started looking forward to her dream of becoming an artist. She attended CCF's Place for Academic Learning and Support (PALS), an infection-controlled interim learning centre for children with cancer, where there were many art activities to hone her interests.

Today, Asfa has returned to mainstream school and is well on her way to become the next Picasso!
